Introduction

The MIID HOMEDEC REKA AWARDS 2016 shall be conferred to Malaysian Institute of Interior Designers (MIID) and Lembaga Arkitek Malaysia (LAM) registered Members practicing Interior Design for works completed between the years 2013 to 30th June 2016 that best exemplify the pursuit of excellence in Interior Design.

Excellence in Interior Design refers to excellence in its design and the consistent translation of its intentions into reality, the concurrent high quality of construction and its beneficial impact on the social, physical and the cultural environment of the country.

Awards shall also be conferred to students whose works reflect good design, problem-solving capabilities and soundness in construction via submissions through their respective schools.

Objectives

- To recognise Malaysian Institute of Interior Designers (MIID) Members and Students who pursue excellence in design which reflect local content in design, detail, material, etc.
- To recognise the client bodies and builders who enable the achievement of excellence in Interior Design.
- To promote the development of quality built interior environments that have beneficial, social, physical and cultural impacts on the community and country.
- To recognise young talent through students' course works in relation to various components of the course.

The Judges for the Awards comprising design luminaries shall be nominated and approved by the MIID Council, and all decisions made by the Judges are final and binding on all entries.

Terms & Conditions

- The MIID HOMEDEC REKA AWARDS 2016 is organised by the Malaysian Institute of Interior Designers (MIID), the "Organiser".
- All submitted projects must be designed by a registered member of MIID.
- Participating professional Interior Designers for Categories 01-12 must also be registered with Lembaga Arkitek Malaysia (LAM) and practicing interior design.
- Projects submitted must be completed between the years 2013 to 30th June 2016.
- Except for the student category, entries may be submitted for one or more projects for any or all categories.
- Entries must be made on the prescribed Entry Submission Form. A separate entry form is required for each project submitted. There are 3 different types of Entry Forms (Professional Entry, Student Entry and Open Category Entry). Please submit only the relevant Entry Form for your chosen award category.
- All materials submitted for MIID HOMEDEC REKA AWARDS 2016 must in no way infringe the copyright laws of Malaysia.
- The entries are submitted and accepted on the agreement by the Entrants
 that there are no restrictions or fees payable for their reproduction by
 the Organiser of the Awards, and that the owner of the premises has
 given consent for nomination. MIID and/or its agents reserve the right to
 reproduce any of the Entry Materials in MIID's media and publications, and
 in other media and publications authorised by MIID.
- The Organiser reserves the right to retain, for any period necessary, all
 materials submitted for the purpose of exhibition and publication and NO
 payment, fee or charge will be made whatsoever to any Interior Designer,
 person or firm for such entries published.
- Participants will be responsible for the delivery and collection of their respective submissions. The organiser as far as possible, will take reasonable precautions to ensure that all submissions are maintained in good condition.
- MIID shall not be responsible for the costs incurred for any of the submissions
- It shall be the sole discretion of the Judges to give Awards for one or more or none of the listed categories. Decisions made are final and no correspondence, queries and matters related directly or indirectly to the Awards will be entertained.
- Shortlisted and Winning entries submitted for previous MIID-organised competitions are not eligible for consideration and are not permitted to be proposed for MIID HOMEDEC REKA AWARDS 2016.
- The winners may be required to present their works upon invitation and request by MIID.
- MIID as the Organiser, reserves the right to amend the the terms and conditions of the MIID HOMEDEC REKA AWARDS 2016 as and when it deems necessary, in the interest and objectives of MIID.

Submission Format

This completed Entry Form must be submitted together with the following:

1. Entry Materials including:

- a) Maximum two (2) A2-sized (Portrait) collages of project photographs and drawings with captions mounted on foam boards
- b) One (1) A4-sized report of not more than ten (10) pages that includes:
 - Client Brief and Design Rationale
 - Drawings / Plans / Sections / Elevations
 - Other particulars of the project
 - List of builders, suppliers, materials, fittings & furnishing (optional)

c) A clearly labelled USB Drive that contains:

- i) High Quality, High Resolution (minimum 300dpi) softcopies of:
 - Items (a) and (b) in JPEG or PDF format
 - Project Photos in JPEG or TIFF format (Maximum of 6)
 - Drawings / Plans / Sections / Elevations in JPEG or PDF format
 - Portrait Photo of the Designer in JPEG format
- ii) Project Description in MS Word format
- iii) Scanned copy if this completed Entry Form in JPEG or PDF format

2. A photocopy of the Entrant's MIID Membership Certificate

3. Entry fees of RM212.00 (inclusive of GST)
